# SELECT™ CAL-KELP 5-0-0

This product is tank mix compatible with most fertilizers and pesticides. However due to the variability in water sources and pesticide formulations a compatibility test is recommended.

GENERAL USE RATES	
<b>TURFGRASS: Warm and Cool Season</b>	Apply 4 to 6 ounces per 1000 sq. feet as needed for maintenance in minimum 1 gallon of water. Applications can be made every 7 to 14 days as needed for desired results
<b>ORNAMENTAL, NURSERY, AND GREENHOUSE:</b>	Apply 1 to 2 quarts per 100 gallons of water every 30 days as needed.
<b>FRUITS, NUTS AND VINE CROPS (Apples, Citrus, Grapes, Peaches, etc.</b>	Apply 1 to 4 quarts per acre beginning at pre-bloom and repeat applications every 2 to 4 weeks through early fruit development.
<b>SMALL FRUITS</b>	<b>(Blackberries, Blueberries, and Strawberries)</b> Apply 2 to 6 quarts/acre every 2 to 4 weeks starting before bloom.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY, SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN
