# SELECT™ MICRO PACK

This product is tank mix compatible with most fertilizers and pesticides. However due to the variability in water sources and pesticide formulations a compatibility test is recommended.

GENERAL USE RATES	
<b>TURFGRASS: Warm and Cool Season</b>	Apply 3 to 6 ounces per 1000 sq. feet as needed for maintenance. For deficiencies apply 8 to 12 ounces per 1000 sq. feet. Applications can be made every 7 to 15 days as needed for desired results.
<b>ORNAMENTAL PLANTS AND TREES</b>	Apply 1 to 2 quarts per 100 gallons of water every 30 days as needed
<b>FRUITS, NUTS AND VINE CROPS (Apples, Citrus, Grapes, Peaches, etc.</b>	Apply 2 to 4 quarts per 100 gallons of water for coverage. Thoroughly wet leaves to run off. Repeat applications as needed in accordance to crop requirements.
<b>SMALL FRUITS</b>	<b>(Blackberries, Blueberries, and Strawberries)</b> Apply 1 to 2 quarts per acre after transplanting or bloom. Reapply every 14 days as needed

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY, SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN
