APPLICATION INFORMATION

Azoxy D Select™ is recommended for the control of more than 20 troublesome diseases on golf course turf only, and is most effective when applied prior to disease development. Apply **Azoxy D Select™** in sufficient spray solution for good turf coverage, which is required for good disease control. Repeat applications at specified intervals for as long as required. For the control of foliar diseases allow **Azoxy D Select™** to dry before irrigation. For the control of soil-borne diseases **Azoxy D Select™** can be watered in after application. **Azoxy D Select™** is a broad-spectrum fungicide containing two active ingredients for application as a foliar spray, in alternating spray programs, or in tank mixes with other registered pesticides. **Azoxy D Select™** is compatible with many commonly used fungicides, liquid fertilizers, herbicides, insecticides, and biological control products. If tank mixes are desired, observe all directions, precautions, and limitations on labeling of all products used.

Under certain conditions conducive to extended infection periods use another registered fungicide for additional applications if the maximum annual amount of **Azoxy D Select™** has already been used. If resistant isolates to Group 11 or Group 3 fungicides are present, efficacy can be reduced for certain diseases. The higher rates in the rate range and/or shorter spray intervals may be required under conditions of heavy infection pressure with highly susceptible varieties, or when environmental conditions are conducive to this disease pressure.
